

## **Temporary Use Permit Supplemental Application Form E**

### **All Other Temporary Uses**

#### **Common Temporary Uses are Included Below.**

##### **SZC 3.10.3.E. Temporary Concession Stands**

Any individual retail sales operation not involving a permanent building, where such operation is to make goods or services available to the general public using a temporary table, stand, cart, or similar equipment; but not including a mobile vending vehicle licensed and operated pursuant to the provisions of the Sacramento County Code. The sale of food for immediate consumption (prepared food) is prohibited unless in compliance with SZC3.10.3.E.15 which requires approval from the Planning Commission (TUZ application and BRB review fee currently \$2,679.38).

##### **SZC 3.10.3.G. Temporary Sales/Construction Office**

Temporary office established during construction of lots and homes, or use of a model home as a temporary office to handle sales of lots or homes. Temporary signs may be permitted, provided said signs are located at the office location. All other signs associated with the subdivision are considered Subdivision Signs and require Supplemental Form C and are subject to the "TSZ" fee in the Planning Fee Schedule.

##### **SZC 3.10.3.H. Temporary Use of Mobile Homes and Commercial Coaches**

Includes use of mobile homes at large construction sites or as temporary night watchman quarters; use of commercial coaches as temporary offices; or use of commercial coaches as temporary classrooms. Does not include use of mobile home for persons in need of care and supervision (SZC 3.10.3.H.2).

##### **SZC 3.10.3.J Recreational Vehicles (RV) at Residential Construction Sites**

An RV may be used as temporary housing (up to one year) at a residential construction site where the primary dwelling is being constructed at the site.
