Staff Public Comment,

I am a concerned resident who has been following the progress of the Sacramento County Climate Action Plan (CAP). It is a disappointing story and so I am writing to ask that you not accept this current draft and require substantial revisions to strengthen the plan.

From courses by the Renaissance Society at CSUS, I learned that Sacramento's largest source of greenhouse gas emissions is vehicle exhaust, an amount that increases increase when more vehicle-miles are traveled within the County. The Sacramento CAP should have the goal of reducing greenhouse gas emissions by reducing total vehicle-miles traveled. This is most directly done by building infill projects inside the urban area rather than extending suburban sprawl. The CAP does not do this. I'm told that over 55,000 new dwelling units are planned beyond the County's growth boundary. Such expansive growth will only increase vehicle-miles driven in the County and will increase greenhouse gas emissions.

A second source of greenhouse gases in Sacramento is from gas-powered heaters and stoves in our buildings. The CAP should address this problem. Third, the CAP's measures don't meet obvious requirements of being clearly stated and enforceable.

The CAP is an opportunity for the County to reduce sprawl, to support infill projects that reduce vehicle-miles given, and to support the construction of green buildings. It is an opportunity to have clear, strong measures to determine our progress. The current CAP misses those opportunities.

Thank you for listening to my concerns about the current draft CAP.
